As an assemblymember, Dr. Garcia advocates for affordable housing (i.e., allocating state funding to housing projects for youth fosters, veterans, and other vulnerable populations to combat against the homelessness crisis), climate change and environmental justice (e.g., air and water quality projects for improvement, restoring the Salton Sea, and cleaning up the Calexico New River), education reforms (i.e., expanding early childhood educational resources and making the pursuit of higher education more accessible and affordable), improving the quality of life for residents (i.e., developing more local parks and green spaces), local business support (e.g., implementing more small business loan programs), expanding workforce training (i.e., to increase job creation and improve the local economy), enhancing veteran resources (e.g., establishing more veteran housing), infrastructure improvements to be eco-friendly (i.e., ensuring energy stability, affordability, and safety while also decarbonizing the electrical grid), improving public health (i.e., increasing the accessibility of health care resources and services and providing free rides to doctor's offices for low-income families), increasing worker protections, strengthening workforce development, supporting local agriculture, ensuring local leaders receive necessary resources (particularly to recover from the COVID-19 pandemic), and expanding equitable economic opportunities (i.e., to create more local and clean energy jobs).

In 2016, Dr. Garcia authored a historic climate change legislation (SB 32 & AB 197), establishing California's landmark emission reduction mandate, and constructed a policy framework prioritizing climate investment for disadvantaged communities most impacted by pollution. Building upon those efforts, in 2017, Dr. Garcia passed AB 398, which developed a statewide climate action plan, and AB 617, the Community Air Protection Program, which serves as a national model of empowering communities to lead the creation of local air quality



action plans. In recognition of his efforts to protect and preserve the environment, Dr. Garcia has received the National Climate Leadership award from the United States Environmental Protection Agency.
