Focus:

As a senator, Wilk advocates for job creation and workforce development (i.e., prioritizing keeping jobs in California, supporting policies that bring mortgage paying jobs to the state, and opposing policies that place economic burdens on already struggling families), ensuring greater accountability from non-elected bureaucrats (e.g., AB 1707 -- requires the State Water Resources Control Board to post scientific peer reviews on its website as it relates to communities having to comply with TMDL standards; this law went into effect on January 1st, 2015), increasing government transparency in the election process (e.g., AB 2551 -- establishing a minimum standard of transparency for the fiscal analysis of local bond measures that is very similar to what the LAO already does for state General Obligation bond measures), bringing accountability to the Fentanyl Crisis, and strengthening public safety (e.g., SB 868 -- would require each school district, county office of education, and charter school to equip each classroom with a trauma kit that includes: One tourniquet, One bleeding control bandage, One pair of non-latex protective gloves and a marker, One pair of scissors, and Approved Instructional documents).

In recognition for working tirelessly to ensure those in Santa Clarita had a voice in the California Legislature, the Signal Newspaper honored Senator Wilk as one of the 51 most influential people in Santa Clarita in 2012. Senator Wilk has continuously provided the necessary resources, support, and representation for his district and for this reason, he was the recipient of Easterseals California's "2018 Senate Champion Award" and the "Compassionate Legislative Champion" Award in 2019, awarded to him by the Social Compassion in Legislation (SCIL). As of present, Senator Wilk was named Co-Chair of 2023 Problem Solvers Caucus, a bicameral, bipartisan group of legislators who prioritize finding meaningful solutions over party ideology.
