CHC Legislative Priority: AB 2303

Minimum wage PPS Add-on

AB 2303 (J. Carrillo) would ensure community health centers have a mechanism to address SB 525 by requiring DHCS to submit a request for approval to the Centers for Medicare and Medicaid Services to authorize a PPS add-on, not subject to reconciliation, to support sustainable implementation of minimum wage increases.

- Location: Assembly Health Committee on 4/16
- CHC ASK: To support our workforce and continue providing excellent, high-quality care to patients, CHCs need a mechanism to implement SB 525. Support AB 2303 when it comes before the you in committee or on the Floor.

CHC Legislative Priority: SB 1067

Supporting a Strong Healthcare Workforce

SB 1067 (Smallwood-Cuevas) will establish a process for healing arts boards to expedite license applications for those health care providers who intend to practice in a medically underserved area or provide care to a medically underserved population.

- Location: Sen. Business and Professions Committee
- CHC ASK: Workforce continues to be a major issue in medically underserved areas in the state and in facilities serving these populations such as community health centers. This bill prioritizes certain applications and does not require new or duplicative efforts by the boards. <u>Support the bill</u> <u>when it comes before the you in committee or on the</u> <u>Floor.</u>



CHC Legislative Priority: SB 1382

Removing Barriers to Provide Access to Care

SB 1382 (Glazer) will streamline licensing and building standard requirements while continuing to provide necessary patient protection. This bill will update the construction and building standards for outpatient clinics and tie them to existing standards for county clinics.

- Location: Senate Health Committee
- CHC ASK: Current heightened standards result in barriers to access patient care because community health centers are required to utilize their funds for unnecessary construction costs rather than expanding services or opening additional sites in underserved areas. <u>Support the bill when it comes</u> <u>before the you in committee or on the Floor.</u>

CPCA Advocates Budget Priorities

MCO Tax

- Ensure CHCs remain funded through the MCO tax in the Fiscal Year 24-25 budget
- Ensure the Supplemental Payment Pool is transitioned to a Directed Payment and the funding supporting this effort is <u>augmented</u> to no less than \$205M/year.
- Encourage the Legislature & Administration to make the proposed provider targeted rate increases not subject to reconciliation; aligning with the MCO tax ballot initiative.
- CHC ASK: Continue funding primary and specialty care and protect CHC funding through the MCO tax.



CPCA Advocates Budget Priorities

AB 2303 Funding

- To address the requirements from SB 525 and support the PPS add-on created by AB 2303, CPCA Advocates are asking for \$1.2 billion annually.
- This request is based on the financial impacts for the minimum wage increases and the increased salary requirements in SB 525.
- CHC ASK: The Legislature passed, and the Governor signed SB 525. We ask for support in successfully & sustainably implementing the law.
